

The Mission Commission Participant Agreement

We are excited that you have decided to participate in The Mission Commission at St. Timothy School. We are committed to offering an educational and spiritual experience of high quality, and to this purpose, it mandates the maintenance of a safe and respectful environment. By participating in The Mission Commission, you will join a community of students and educators and will be asked to conduct yourself in a manner which demonstrates respect for yourself, your fellow club members, adult leaders and St. Timothy School.

1. Behavior:

We require that all club members behave as mature, responsible, and respectful citizens. Reckless behavior that results in injury to others or damages School or community property will not be tolerated. While participating in the club, you will be treated with respect, and in return, we ask that you help foster an atmosphere of respect and trust through your relationships with fellow club members, counselors, staff, faculty members and guests.

The St. Timothy School Code of Conduct applies to club meetings and activities. If you engage in inappropriate or irresponsible behaviors an adult volunteer will contact your parent or guardian who will be responsible for picking you up from the meeting or activity immediately.
